WORK STOPPED BY CLIENT MAY BE CONSIDERED CANCELLED AFTER 30 DAYS. IN THE EVENT OF CANCELLATION OF THIS ASSIGNMENT, OWNERSHIP OR ALL COPYRIGHTS AND THE ORIGINAL ARTWORK AND DISKS ARE RETAINED BY THE DESIGNER. CLIENT MAY NOT USE OR APPROPRIATE SAID ITEMS OR CONCEPTS WITHOUT RETAINING PERMISSION, IN THE FORM OF A WRITTEN AGREEMENT, FROM DESIGNER.

UPON PAYMENT IN FULL, THE CLIENT SHALL RETAIN COPYRIGHT FOR ARTWORK FOR THIS ASSIGNMENT.

BOTH PARTIES AGREE THAT THE DESIGNER MAY EXHIBIT ARTWORK FOR THE PURPOSES OF SELF-PROMOTION.

DESIGNER PROMISES THAT ARTWORK WILL NOT BE SOLD OR LICENSED TO ANY PARTY OTHER THAN THE CLIENT NAMED

IN THIS AGREEMENT.

THE DESIGNER WARRANTS AND REPRESENTS THAT, TO THE BEST OF HER KNOWLEDGE, THE WORK GENERATED BY THE DESIGNER IS ORIGINAL AND HAS NOT BEEN PREVIOUSLY PUBLISHED OR THAT CONSENT TO USE HAS BEEN OBTAINED ON AN UNLIMITED BASIS.
